



INVITATION TO BID

FOR THE SUPPLY AND INSTALLATION OF ONE (1) UNIT GENERATOR SET FOR THE OFFICE OF THE DEPUTY OMBUDSMAN FOR LUZON

The Office of the Deputy Ombudsman for Luzon through the General Appropriations Act intends to apply the sum of **Seven Hundred Forty Thousand Pesos (₱ 740,000.00)** being the Approved Budget for the Contract (ABC) as payment for **Public Bidding for the Supply and Installation of One (1) Unit Generator Set** for the use of Office of the Deputy Ombudsman for Luzon. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Office of the Deputy Ombudsman for Luzon now invites bids for the **Supply and Installation of One (1) Unit Generator Set**. Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding. The description of an eligible bidder is contained in the Bidding Documents and Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138. Interested bidders should be enrolled to the Electronic Filing and Payment System (eFPS) program of the Bureau of Internal Revenue (BIR), pursuant to Executive Order No. 398, RR 3-2005, and must be registered under the Philippine Government Electronic Procurement System (PhilGEPS).
