Assistant Ombudsman Bayani Jacinto of the Office of the Deputy Ombudsman for Luzon forges ahead in his career in the judiciary with his appointment by President Rodrigo

Duterte as associate justice of the Sandiganbayan on May 29, 2017.

Filling up the seat vacated by retired justice Roland Jurado, Jacinto brings to the *Sandiganbayan* his deep and solid

background in prosecuting and monitoring criminal and administrative cases at the Office of the Ombudsman.

When the news of the appointment was released, Ombudsman Conchita Carpio Morales and AO Jacinto were in the same hall attending an Ombudsman event. The Ombudsman took no time in congratulating the appointee to the anti-graft court. "The Ombudsman's loss is the *Sandiganbayan's* gain," said the Ombudsman.

AO Jacinto took his oath before Supreme Court Chief Justice Maria Lourdes PA Sereno on May 30, 2017. The Ateneo Law School alumnus assumed his post as the 67th justice of the *Sandiganbayan* since the court's establishment in 1978.

The *Sandiganbayan* is a collegial court consisting of 21 justices distributed among 7 divisions. Associate Justice Jacinto currently sits as a junior member of the court's 4th division.

ment the controversial Disbursement Acceleration Program (DAP) involving P72 billion. NBC No. 541 authorizes the withdrawal of unobligated allotments of agencies with low levels of obligations as of June 30, 2012.

In addition, Abad was found guilty of Simple Misconduct and ordered sus-

pended for three months. However, considering his separation from the service, the penalty is convertible to a fine equivalent to his salary for three months.

The cases arose from the complaint filed by Representative Carlos Isagani Zarate, Renato Reyes, Benjamin Valbuena, Dante LA Jimenez, Mae Paner, Antonio Flores, Gloria Arellano and Bonifacio Carmona, Jr.

During the investigation, the Ombudsman found that by issuing NBC No. 541, Abad unlawfully encroached on the powers of Congress by effectively modifying the provisions on savings of the 2012 General Appropriations Act (GAA).

Ombudsman Conchita Carpio Morales has ordered the dismissal from the service of 21 Senate staff after they were found guilty of Grave Misconduct, Conduct Prejudicial to the Best Interest of the Service and Dishonesty over the illegal utilization of the Priority Development Assistance Funds (PDAF) of former Senators Ramon "Bong" Revilla Jr., Juan Ponce Enrile, and Jose "Jinggoy" Estrada. Ombudsman meets with Chinese anti-corruption officials

The Office of the Ombudsman welcomed officials from the National Bureau of Corruption Prevention (NBCP) and the Department of International Cooperation of the CPC Central Commission for Discipline Inspection and Ministry of Supervision from the People's Republic of China on April 10, 2017.

Ombudsman Conchita Carpio Morales received the delegation from the People's Republic of China including representatives from the China Embassy.

Top ranking officials of the Office of the Ombudsman presented an overview of the functions, powers, initiatives and milestone accomplishments of the Office. The meeting, which was held upon the request of the People's Republic of China, explored the possibility of conducting bilateral cooperation initiatives between the NBCP and the Ombudsman towards the establishment of the China-ASEAN anti-corruption cooperation mechanism.

The delegation from the People's Republic of China was headed by Vice Minister Liu Jianchao of the NBCP and Director General of Department of International Cooperation of the Central Commission for Discipline Inspection and Ministry of Supervision. The Vice Minister was joined by Deputy Chief of Mission He Xiangqi, Division Director Jia Luan, Division Director Wang Qing, Deputy Division Director Ma Jian, Ms. Qian Yangjing and Mr. Chen Qingjie.

Established in 2007, the NBCP aims to monitor the flow of

suspicious assets and corruption activities by establishing an information-sharing system among prosecuting offices, courts, police authorities and banks. NBCP also guides anti-corruption work in companies, public undertakings and non-governmental organizations, help trade associations to establish self-discipline systems and mechanisms, prevent commercial bribery, and extend corruption prevention work to rural organizations as well as urban communities.

the Ombudsman and the student organizations in the different school divisions in the National Capital Region. The whole gamut of the social media structure—of which Facebook and Twitter have become indispensable—serves as a node of integrity, where learning from each others' insights and activities has become instantaneous.

A case-in-point: Anna Kristina Mutuc of Garcian Integrity Movers, whose Share-A-Wisdom project seeks to impart nuggets of wisdom from the lens of a student leader, has this to say:

"(It) is one of my favorite activities because as President of the organization, I am given the chance to speak during flag raising ceremony. *Ipinapalaganap* ko po sa mga kapwa mag-aaral ng aming paaralan ang tungkol sa kahulugan, katuturan at kahalagahan ng integridad sa poamamagitan ng paglalahad ng mga kuwento hango sa totoong buhay," relayed the student leader in her testimonial speech as representative of one of the outstanding student organizations. Mutuc's compelling prose, especially the part where she relates 'real life insights,' takes on a 'life of its own' when mediated by the power of Facebook and Twitter.

"With the active involvement of the officers of the Campus Integrity Crusaders in their respective schools/campuses and with the support of social media through the CIC Fan Page, these young leaders are able to understand and identify with the values of integrity and social responsibility," said the Office of the

Ombudsman's Community Coordination Bureau (CCB) Acting Director Rhodora Galicia.

Aside from the lectures and project syntheses, the *Third Campus Integrity* Crusaders Congress also served as an opportune time for affirming the students' noble pursuits. This year's roster of outstanding student organizations includes: (Manila) Monsay Integrity Movers, Ramon Magsaysay High School, "Kultura ng Katapatan Pinanday sa Paaralan Para sa Malinis na Bayan", Garcian Integrity Movers, Carlos P. Garcia High School, "TAMA KA GARCIAN (Turuan, Akayin sa Mabuting Asal**K**Abataang GARCIAN", Rectonian Integrity Movers, Claro M. Recto High School, "Kabataang May Integridad: Kabataang May Responsibilidad"; Apart from the dismissal, the respondents were also permanently banned from holding public office and their retirement benefits forfeited. In the event of their separation from the service, the penalty would be converted to a fine equivalent to their salary for one year.

The dismissed employees are also being tried before the Sandiganbayan for their involvement in the anomalous utilization of the PDAF of the former solons.

From 2007 to 2009, the amounts of P517,000,000, P345,000,000, and P278,000,000 were released by the Department of Budget and Management as part of the PDAF of Revilla, Enrile, and Estrada. After the fund release, the former lawmakers identified the NABCOR, NLDC and TRC as implementing agencies. They authorized their high-ranking staff members to act for them, deal with, and sign documents necessary for the immediate and timely implementation of the PDAF-funded projects to facilitate the scam.

Their multi-million fund was allegedly used to buy materials, products, and services needed for each of their NGOs project-beneficiaries.


Actual field validation conducted by the Ombudsman revealed that no delivery was made to the supposed beneficiaries.

Mayors and municipal agriculturists denied receiving any of the items from the office Senator Revilla, Enrile, and Estrada, the implementing agencies or any of the NGOs.

The Ombudsman highlighted "the extraordinary speed attendant to the examination, processing and approval by the concerned NABCOR, NLDC and TRC officers of the PDAF releases to the Napoles-affiliated or controlled NGOs."

The decisions states that, "based on testimonial and documentary evidence presented, the widespread misuse of the PDAF allotted to a legislator was coursed through a complex scheme basically involving projects supposed to have been funded by said PDAF which turned out to be inexistent or "ghost projects."

According to Ombudsman Morales, "in most instances, the disbursement vouchers (DV) were accomplished, signed and approved on the same day. Certainly, the required careful examination of the transaction's supporting documents could not have taken place if the DV was processed and approved in one day.

According to Ombudsman Morales, "NBC No. 541 provided the principal bases for the withdrawal of unobligated allotments which were declared as savings and used to fund PAPs (programs, activities and projects) under the DAP. The issuance of this circular is an act of usurpation. This is contrary to law."

It will be recalled that in 2014, the Supreme Court declared as unconstitutional the following acts committed in pursuance of the DAP: (1) withdrawal of unobligated allotments from the implementing agencies; and the declaration of the withdrawn unobligated allotments and unreleased appropriations as savings prior to the end of the fiscal year without complying with the statutory definition of savings contained in the GAA; and (2) the cross-border transfers of the savings of the Executive to augment the appropriations of other offices outside the executive.

Under Article 239 of the RPC, the penalties of *prision* correccional in its minimum period and temporary special disqualification, shall be imposed upon an executive or judicial officer who shall encroach upon the powers of the legislative branch of the Government, either by making general rules or regulations beyond the scope of his authority, or by attempting to repeal a law or suspending the execution thereof.

Top officials of the Office of the Ombudsman and the Philippine Competition Commission (PCC) held exploratory talks on the crafting of a Memorandum of Understanding on June 28, 2017 at the Conference Room of the OMB Proper.

The PCC delegation was led by Chairman Arsenio Balisacan and Commissioners Stella Luz Quimbo, Amabelle Asuncion and Johannes Benjamin

The expected output seeks to harness the agencies' anti-corruption mandates. Specifically, the PCC is tasked by Republic Act 10667 or the Philippine Competition Act to promote fair market competition and prevent the commission of anti-competitive agreements, mergers and acquisitions.



OMB, COA ink MOA on joint investigation of grand corruption cases

The Office of the Ombudsman and the Commission on Audit (COA) inked anew a Memorandum of Agreement to strengthen their institutional partnership on the Joint Investigation Team Cases (JIT cases).

Ombudsman Conchita Carpio Morales and COA Chairman Michael Aguinaldo signed the MOA in a simple ceremony held at the EDSA Shangri-La in Mandaluyong City on 28 February 2017. Deputy Special Prosecutor Mary Susan Guillermo and Assistant Commissioner Alexander Juliano witnessed

the signing ceremony. Also present during the signing were high ranking officials from both agencies, development partners and anti-corruption stakeholders.

In her keynote address, Ombudsman Morales said that she expects the fast tracking of JIT cases to meet the people's expectation for speedy disposition of graft and corruption related offenses. Meanwhile, Chairman Aguinaldo thanked the Ombudsman and the USAID Integrity for Investments Initiative (i3) as development partner, as he underscored the

importance of the institutional collaboration especially for high value, high profile cases which require prioritization.

Under the MOA, JIT cases are fraud audit-related complaints or reports involving at least P100M or its equivalent in kind or in other currencies, graft and corruption cases investigated by the Congress, and other cases imbued with public interest regardless of the amount. In addition, it provided for the establishment of a "JIT Priority Lane" in the Office of the Ombudsman where JIT cases shall be immediately filed,

docketed and subjected to preliminary investigation.

The MOA is part of the anti-corruption initiatives of the Inter-Agency Anti-Graft Coordinating Council presently chaired by Aguinaldo. It will be recalled that in 2012, former COA Chair Grace Pulido-Tan and Ombudsman Morales also signed a MOA to ensure the efficient and successful filing, investigation and prosecution of cases involving graft, corruption and violations of the ethical code of conduct for public officials and government employees. The program ran for three years.

In a signing ceremony held on February 27, 2017, Ombudsman Conchita Carpio Morales and members of the negotiating panels witnessed the signing of the CNA between Overall Deputy Ombudsman Melchor Arthur Carandang and OMBEA President Nolasco Ducay.

"It's good that the negotiations didn't fall apart. I commend the members of the negotiating panels for successfully leading the talks to their rightful conclusion," said Ombudsman Morales when sought for a reaction after the historic signing.

The members of the negotiating panel for the Office of the Ombudsman include Deputy

Ombudsman (DO) for the MOLEO Cyril Ramos. DO for Luzon Gerard Mosquera, DO for Visayas Paul Elmer Clemente, DO for Mindanao Rodolfo Elman, Assistant Ombudsman (AO) Edna Diño, AO Leilanie Bernadette Cabras and AO Weomark Ryan Layson while their counterparts from the OMBEA are Harry Crisanto Ravelo, Lionell Donato, Noel Valencia, Joanna Mae Alberto, Roderick Angeles and Gerhard Basco.

In an *Integrity Watch News* interview, OMBEA Secretary Bernadette Cunanan said that in 2004, a similar CNA was approved although it was not registered with the Civil Service Commission as required by law. "So the approval and registration of the 2017 CNA is a welcome development and we thank the present management under Ombudsman Morales for supporting the CNA," said Cunanan.

The 2017 CNA embodies the rights, privileges and incentives that members of the OMBEA can avail of. Its salient features include provisions

which strengthen the employees' security of tenure and clearer grievances. The CNA also provides for a CNA incentive, subject to pertinent rules and availability of funds, to "association members, rank-and-file employees who are not members of the Association, and those performing

Meanwhile, the provision on flexible office hours under the "Employee Welfare and Professional Development" clause of the CNA has already been implemented effective April 3,2017.
