### Data Collection and Use

The website collects data from the following online forms incorporated into its structure as a service to its users:

The website's web server automatically collects some information about a visitor's computer or other access device, such as its Internet protocol address or browser version, in their logs. This information is used in aggregate form for security and analytics purposes.

### **Web browser cookies**
