



INVITATION TO BID

For 3rd Negotiated Procurement for the Supply and Delivery of Two (2) Units Brand New Asian Utility Vehicles requirement of the Office of the Deputy Ombudsman for Luzon

The Office of the Deputy Ombudsman for Luzon, through its Bids and Awards Committee (OMB-Luzon BAC), intends to procure thru Negotiated Procurement (Two Failed Biddings) pursuant to Section 53.1 of the Implementing Rules and Regulations of R.A. No. 9184, the **Supply and Delivery of Two (2) Units Brand New Asian Utility Vehicles (AUVs)**, with Approved Budget for the Contract (ABC) of **Two Million Two Hundred Thirty Thousand Pesos (P2,230,000.00)**.

Proposals shall be submitted using the forms specified in the bidding documents in two (2) separate sealed bid envelopes which shall be submitted simultaneously on or before **May 27, 2016 at 9:45 a.m.**

Both Technical and Financial Proposals shall be opened on **May 27, 2016** at exactly **10:00 a.m.** at the OMB-Hearing Room (Mock Trial Room).
