**INVITATION TO BID PROVISION OF JANITORIAL SERVICES**

The **OFFICE OF THE OMBUDSMAN (VISAYAS) REGIONAL OFFICE VI**, through its General Appropriations Act of 2015 intends to apply the amount of **ONE HUNDRED FORTY FOUR THOUSAND ONE HUNDRED NINETY TWO PESOS (P144,192.00)** and invites all interested and legitimate contractors to apply for eligibility and submit bids for the hereunder project:

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. Prospective bidders should have at least **five (5) years** experience in undertaking frontline security services for the period 2011 to 2015. The bidders should have had a single contract similar to the Project with an amount of at least 50% of the ABC. The bidders should conform to the eligibility criteria as prescribed under the Revised Implementing Rules and Regulations of Republic Act No. 9184.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested Bidders subject to the conditions for eligibility provided in the IRR of RA 9184.

No. (033) 5094655 within the government prescribed office hours, or inspect the Bidding Documents at Office of the Ombudsman (Regional Office VI), 2<sup>nd</sup> Flr. CAP Bldg., Gen. 6. Only those Bidders who shall pay the nonrefundable fee in the amount of PhP 500.00 for the Bidding Documents can participate in the bidding. The Opening of Bids shall be on November 3, 2016, 2:00 P.M. at the Office of the Ombudsman (Regional Office VI), 2<sup>nd</sup> Flr. CAP Bldg., Gen. Luna St., Iloilo City. Late bids shall not be accepted.
7. The **Office of the Ombudsman** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
