Re: Award for PB-2018-07

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 173 (Series of 2018), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

WHEREAS, on May 30, 2018, the Invitation to Bid for **PB 2018-07: Public Bidding of One (1) Year License Subscription and Technical Support for the Ombudsman-Wide Connectivity of the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

WHEREAS, the total Approved Budget for the Contract (ABC) for **PB 2018-07: Public Bidding of One (1) Year License Subscription and Technical Support for the Ombudsman-Wide Connectivity of the Office of the Ombudsman** is **Two Million Four Hundred Fifty Thousand Pesos (Php2,450,000.00)**.

WHEREAS, for the period from May 30, 2018 to June 18, 2018, one (1) prospective bidder¹ bought the bid documents.

WHEREAS, a Pre-Bid Conference was conducted on June 06, 2018 at 1:30 p.m. with one (1) prospective bidder² in attendance.

WHEREAS, on June 18, 2018³, one (1) bidder submitted their bid before the 1:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG). After evaluation of eligibility and technical components of Microgenesis Software, Inc., doing business under the name and style of Microgenesis Business Systems the BAC declared the bidder as "**eligible**". Thus Envelope No. 2 containing the financial proposal was opened, to wit:
