BAC Resolution No. 12-2018 (PB)
Series of 2018

Re: Award for PB 2018-12

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 173 (Series of 2018), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

WHEREAS, on July 04, 2018, the Invitation to Bid for **PB 2018-12: Public Bidding for the Procurement of One (1) Year Courier Services Requirement of the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

WHEREAS, the total Approved Budget for the Contract (ABC) **PB 2018-12: Public Bidding for the Procurement of One (1) Year Courier Services Requirement of the Office of the Ombudsman is One Million Two Hundred Ninety Two Thousand Four Hundred Twenty Five Pesos (Php1,292,425.00)**.

WHEREAS, for the period from July 04, 2018 to July 24, 2018, four (4) prospective bidders¹ bought the bid documents.

WHEREAS, a Pre-Bid Conference was conducted on July 11, 2018 at 2:30 p.m. with three (3) prospective bidders² in attendance.

WHEREAS, on July 24, 2018, four (4) bidders³ submitted their bid before the 2:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of their eligibility and technical components, the BAC declared the three (3) bidders namely: LBC Express Inc., Libcap Super Express Corp. and Premiere Logistics Inc. as **"eligible"**, while Intertraffic Transport Corp., was declared as **"ineligible"**. Thus Envelope No. 2 containing the

financial proposals of LBC Express Inc., Libcap Super Express Corp. and Premiere Logistics Inc., were opened, to wit:

WHEREAS, on July 30, 2018, after the TWG conducted a detailed evaluation of bids for arithmetical computation, it has resulted to the disqualification of LBC Express Inc. due to submission of bid in excess of Approved Budget for the Contract (ABC), to wit:

WHEREAS, the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on July 31, 2018, to Libcap Super Express Corp., having the Lowest Calculated Bid. After validation and verification, the TWG determined that the Libcap Super Express Corp. complied with the OMB technical specifications and are responsive to all the legal requirements and conditions for eligibility.

NOW, THEREFORE, the undersigned members of the Bids and Awards Committee hereby **RESOLVE** and **RECOMMEND** for approval of the **award of contract** of **LIBCAP SUPER EXPRESS CORPORATION** having submitted the **Lowest Calculated and Responsive Bid** of **₱1,164,655.00**, subject to the posting of a bond to guarantee performance.




