

# CONTRACT AGREEMENT

## KNOWN ALL MEN BY THESE PRESENT:

**LIBCAP SUPER EXPRESS CORPORATION** with business addresses at LIBCAP Commercial Building Brgy., Quintin Salas, Jaro Iloilo City and Blk. 1 Lot 2 Multinational Village Multinational Ave., Brgy. Sto Niño Parañaque City, represented by **MS. MARIA LUCIA G. MONDRAGON**, President, hereinafter referred to as "the SUPPLIER".

## WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of One (1) Year Courier Services Requirement of the Office of the Ombudsman** (PB 2018-12) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of One Million One Hundred Sixty Four Thousand Six Hundred Fifty Five Pesos (**Php1,164,655.00**) (hereinafter called "the Contract Price"), to wit:

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) the Financial Proposals (Annex "A");
- (b) the Technical Proposals and Omnibus Sworn Statement with Secretary's Certificate (Annex "B" and "B-1");
- (c) the Schedule of Requirements (Annex "C");
- (d) the Technical Specifications (Annex "D");
- (e) the General Conditions of Contract (Annex "E");
- (f) the Special Conditions of Contract (Annex "F");
- (g) the Entity's Notice of Award (Annex "G"); and
- (h) the Performance Security (Annex "H")


3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.




