Guzman and Mr. James Tomada. (The following were the late comers: Mr. Mike Sevilla from WESTCON; Ms. Joebel Ann Murillo from TRENDS and Mr. Yeng Encarnacion from NUTANIX. (A total of seven (7) prospective bidders in attendance.)

- The Invitation to Bid (ITB) was posted at the PhilGEPS, Ombudsman Website and BAC Bulletin Board on 19 September 2018. It was also published in the Manila Times, a newspaper of national circulation on the same day;

With the presence of the Chairperson and three (3) Members of the Bids and Awards Committee and the Chairperson and three (3) Members of the Technical Working Group (TWG), a quorum to transact business was manifested by Ms. Vargas.

The Pre-Bid Conference was called to order by AO Maribeth T. Padios, BAC Chairperson. She then turned over the floor to the Technical Working Group for the discussion of the eligibility, technical component, financial component and post-qualification documents.

The TWG Chairperson, Dir. Alan R. Cañares discussed the Invitation to Bid and eligibility requirements and also the requirements for post-qualification to be submitted by the bidder having the Lowest Calculated Bid. Subsequently, Mr. Isagani L. Osio, Vice-Chairperson of the TWG discussed the technical specifications for the project.

Following this, AO Padios opened the floor to answer queries from the participants and encouraged the them to ask questions. She reminded them that any further question after the Pre-Bid Conference will have to be in writing and addressed to the BAC Secretariat.

(Mr. Collado): On the requirement: "Statement of bidder's Single Largest Completed Contract (SLCC), within the year 2013 to present, similar to the contract to be bid," would you allow similar projects to be a combination of "servers and storage?" Would that be considered as similar contracts?	BAC (Dir. Lopez): The guide post is that as long as the major components of the project that you are going to declare are similar to the current project to be bid. The bidders are advised to follow how the law defines "similar projects" based in RA 9184.  TWG (Dir. Cañares): We do not require the projects to be identical; they just have to be similar.

ADVANCE SOLUTIONS, INC. (Mr. Collado): So the Building 1 and 2 reside in Agham, which is high-availability in configuration. And the DR is in Cebu or	that we have three (3) nodes: this Main building, Annex building and in Cebu or Davao. Technically, the Main building and Annex Building is in HA node (high availability). The real DR is in Cebu or Davao. That is how we see the project.  TWG (Mr. Osio): Yes.

TRENDS: On the Firewall requirement "Security features: application control, URL filtering, threat prevention, sandboxing/zero-day protection, IPS, HTTPS decryption, QoS, AD/LDAP integration," what are your expectations on the HTTPS decryption?	TWG (Mr. Osio): For the data that are encrypted, the firewall should decrypt it before it will be inspected.
PROPOSAL	TRENDS: What are your expectations on the decryption? In plain text or something else?	TWG (Mr. Osio): Decryption means conversion to plain text. Encryption means conversion to garbled or unreadable format. It converts back to an encrypted format when it goes out to the firewall.
	TRENDS (Ms. Antonette Martinez-Esteban): On the delivery option (Delivery, transport, hauling, installation, configuration, integration, migration, and testing of required components to all designated sites) are we going to deliver it directly to Cebu or Davao? Will it not pass through here in the headquarters?	TWG (Dir. Cañares): The Technical Inspection (and Acceptance) Committee (TIAC) will be here in Agham Road. Before mounting it there in Cebu or Davao, Inspection shall be done here first before delivering it there.
OMBUDSMAN BID FORM NO. 1-TECHNICAL PROPOSAL	TRENDS (Ms. Martinez-Esteban): Would it be possible that the inventory be done in our warehouse and be forwarded to the distinct location? We will just request your presence there during the testing and inventory.	BAC (Dir. Lopez): The TIAC would be a different group. The Technical Working Group (TWG) is involved until we issue the Notice to Proceed. After that it is a different set of individuals so we have no control whether the TIAC will undertake to visit your warehouse prior to delivery to Cebu or Davao. And normally, we have never experienced that the inspection would be done outside of the Ombudsman premises. Unless there is another arrangement, that would be approved by the HOPE.

		TWG (Mr. Osio): (The) usual practice is that delivery would really be here because you will configure it here. Before sending it out, it should already work.

(Ms. Ling Gonzales): We had an experience that the office could not confirm as to where the DR would be and it has already exceeded the warranty period. How are you going to approach that if it happens?	TWG (Dir. Cañares): We are really not expecting that we will have an issue regarding that because the identification of the particular site, whether in Cebu or in Davao, will be arrived at by the Office of the Ombudsman and whoever is going to win. We did not identify (the site) specifically to be in Davao or in Cebu because we also need you. The reason why we cannot answer because the risk is too remote (warranty is three years).
OMBUDSMAN BID FORM NO. 1-TECHNICAL PROPOSAL	TRENDS (Ms. Martinez-Esteban): Once we deliver it, the activities that would happen would be inventory, testing, inspection, configuration and setup. And from that, will we be able to receive the acceptance or is it right after the delivery of the equipment?	TWG (Dir. Cañares): The acceptance would not be by piecemeal. The acceptance would be upon completion.

(Mr. Collado): Clarification on page 74, bullet number 3 of the bidding documents: "Global Server Load Balancer for redundant connection of intranet applications and internet connections", is this also part of the hardware that we are going to supply even if it is not listed?	TWG (Mr. Osio): We did not list it because we described it as a feature.
	ADVANCE SOLUTIONS, INC. (Mr. Collado): What connection will link the three (3) sites?  ADVANCE SOLUTIONS, INC. (Mr. Collado): None in Cebu?	TWG (Mr. Osio): Currently SD1, and we are using Silver Peak as our connection.  TWG (Mr. Osio): Actually we are using fiber here but in the sites, SD1

Guzman): DR Site, Page 74 on the specification: "UPS with 4 hours backup power on full load on all new hardware acquisition," can we adjust this to at least two (2) hours anyway this requirement is like a generator set.	Silverpeak.  TWG (Mr. Osio): The rack is only for the servers. For the UPS, if you want to have it set up, it would have to be another rack. This rack is for servers only.

Or should we provide modules and stacking cable?	TWG (Mr. Osio): The existing core switch model is HP brand.  TWG (Mr. Osio): For all the necessary accessories, you should provide it (cables, transceivers, etc.).

Can you identify what are the	TWG (Dir. Cañares): We are only requiring an official training course from a certified resource person. It need not be a certification training. We just want the transfer of technology.
OMBUDSMAN BID FORM NO. 1-TECHNICAL PROPOSAL	major components of the HCI?	TWG (Mr. Osio): There are 2 sets: First is the training for the project (HCI) and second is the training for Business continuity planning / implementation, Disaster recovery planning / implementation, and Incident response planning / implementation. For the second set, this is the official training course and courseware. But for the HCI infrastructure, only a certified resource person.
OMBUDSMAN BID FORM NO. 1-TECHNICAL PROPOSAL	TRENDS: Just a clarification, one (1) training for the Primary, and for the Cebu or Davao personnel?	We do not require a certification exam.  TWG (Mr. Osio): We will be the one to identify who will attend the trainings from Cebu or Davao.  TWG (Dir. Cañares): The training will be conducted in Manila and the transportation expenses of the personnel will be borne by us.
OMBUDSMAN BID FORM NO. 1-TECHNICAL PROPOSAL	MICROBASE (Ms. Rose D. Guzman): Clarification on the major components. These major components are HCI and its major components. When you say "major components," does these include firewall, load balancer, network switch?	TWG (Mr. Osio): Major components of the HCI only.

OMBUDSMAN BID FORM NO.	Will you only provide the existing network to the winning bidder?	TWG (Dir. Cañares): You can conduct an ocular inspection. You may get in touch with the BAC Secretariat for the schedule.
1-TECHNICAL PROPOSAL		BAC (Dir. Lopez): We will do the ocular inspection one-time only. We will have it posted so that all the bidders, even those who were not present today, can also join the ocular inspection.

After the open forum, Dir. Cañares proceeded to explain the contents of the Ombudsman Bid Form No. 2 (Financial Proposal). Then the BAC Secretariat showed a short video on how the bidders should prepare their bids for submission.
