

# CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Contract is executed and entered into for all intents and in all respects at Quezon City, Philippines on this 26<sup>th</sup> day of October, 2018, by and between:


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (b) the Schedule of Requirements (**Annex "B"**);
  - (c) the Technical Specifications (**Annex "C"**);
  - (d) the General Conditions of Contract (**Annex "D"**);
  - (e) the Special Conditions of Contract (**Annex "E"**);
  - (f) the Entity's Notification of Award (**Annex "F"**); and
  - (g) the Supplier's Performance Bond (**Annex "G"**).
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




