Re: Award for PB-2018-09

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 173 (Series of 2018), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

WHEREAS, on August 30, 2018, the Invitation to Bid for **PB 2018-09: Public Bidding for the Supply, Delivery and Installation of Modular Partitions including its Accessories and Furniture and Fixtures for the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

WHEREAS, the total Approved Budget for the Contract (ABC) for **PB 2018-03: Public Bidding for the Supply, Delivery and Installation of Modular Partitions including its Accessories and Furniture and Fixtures for the Office of the Ombudsman** is **Three Million Seven Hundred Sixteen Thousand Eight Hundred Eighty Pesos and Fifty Seven Centavos (₱3,716,880.57)**, categorized as follows:

WHEREAS, for the period from August 09, 2018 to August 30, 2018, four (4) prospective bidders¹ bought the bid documents.

WHEREAS, a Pre-Bid Conference was conducted on August 17, 2018 at 2:30 p.m. with four (4) prospective bidders² in attendance.

WHEREAS, on August 30, 2018, four (4) bidders³ submitted their bid before the 1:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of their eligibility and technical components, the BAC declared the three (3) bidders namely: Distinctive Blinds and Office Systems, Inc., Roseco Marketing Ventures and Design Excellence Home & Office System as **“eligible”**, while HY Int’l Unlimited Trading Co. Inc., was declared as **“ineligible”**. Thus Envelope No. 2 containing the financial proposals of Distinctive Blinds and Office Systems, Inc., Roseco Marketing Ventures and Design Excellence Home & Office System, were opened, to wit:

WHEREAS, the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on September 06, 2018 to Roseco Marketing Ventures (having the Lowest Calculated Bid for Lot 1, Lot 2, Lot 3, and Lot 4 & Lot 5). After validation and verification, the TWG determined that the Roseco Marketing Ventures complied with the OMB technical specifications and are responsive to all the legal requirements and conditions for eligibility.

NOW, THEREFORE, the undersigned members of the Bids and Awards Committee hereby **RESOLVE** and **RECOMMEND** for approval of the **award of contract for Supply, Delivery and Installation of Modular Partitions including its Accessories and Furniture and Fixtures for the Office of the Ombudsman to ROSECO MARKETING VENTURES** having submitted the **Lowest Calculated and Responsive Bid** of **₱395,600.00** for Lot 1, **₱530,000.00** for Lot 2, **₱92,700.00** for Lot 3, **₱317,440.00** for Lot 4 and **₱559,152.74** for Lot 5, subject to the posting of a bond to guarantee performance.






