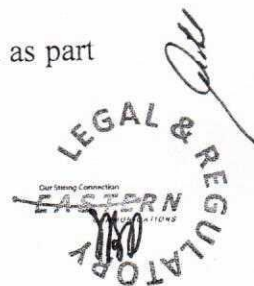
WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply, Installation and Configuration of Internet Bandwidth for the Office of the Ombudsman** (PB 2018-17) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Seven Hundred Thirty Nine Thousand Two Hundred Pesos (**₱739,200.00**) (hereinafter called "the Contract Price"), to wit:

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.


4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
