

# CONTRACT AGREEMENT

**DIGITAL NETWORK COMMUNICATIONS & COMPUTERS, INC.**, with business address at 30F Antel Global Corporate Center, Julia Vargas, Ave., Ortigas, Pasig City, represented by **MS. MARIETTA AUSTRIA**, Channel Sales, hereinafter referred to as "the SUPPLIER".

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply, Delivery, Installation and Configuration of Extended Structured Cabling with Network Switch Devices for the Office of the Ombudsman** (PB 2018-23) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Four Million Nine Hundred Twenty-Seven Thousand Pesos (**₱4,927,000.00**) (hereinafter called "the Contract Price"), to wit:

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) the Financial Proposals (Annex "A");

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.






