

# CONTRACT AGREEMENT

## WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply, Delivery, Installation, Configuration, Migration and Testing of Disaster Recovery Infrastructure for the Office of the Ombudsman-Central Office and Recovery Site** (PB 2018-24-Rebidding) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Thirty Four Million Nine Hundred Thousand Pesos (**₱34,900,000.00**) (hereinafter called "the Contract Price"), to wit:

- (f) the Special Conditions of Contract (Annex "F");
- (g) the Entity's Notice of Award (Annex "G"); and
- (h) the Performance Security (Annex "H")


