

BIDS AND AWARDS COMMITTEE BAC Resolution No. 22-2018 (PB) Series of 2018

Re: Award for PB-2018-26

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 173 and Office Order No. 735 (Series of 2018), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

WHEREAS, on August 24, 2018, the Invitation to Bid for PB 2018-26: Public Bidding for the Supply and Delivery of Brand New Air-conditioning units, Air Curtains and Evaporative Air Coolers for the Office of the Ombudsman, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

WHEREAS, the total Approved Budget for the Contract (ABC) PB 2018-26: Public Bidding for the Supply and Delivery of Brand New Air-conditioning units, Air Curtains and Evaporative Air Coolers for the Office of the Ombudsman is One Million Three Hundred Twenty Thousand Pesos (Php1,320,000.00), broken down as follows: Lot 1- 12 units- Air-Conditioning Units- ₱1,000,000.00; Lot 2- 4 units- Air Curtains- ₱120,000.00; and Lot 3- 4 units- Evaporative Air Coolers- ₱200,000.00.

WHEREAS, for the period from August 24, 2018 to September 17, 2018, two (2) prospective bidders¹ bought the bid documents.

WHEREAS, a Pre-Bid Conference was conducted on September 03, 2018 at 1:30 p.m. with five (5) prospective bidders² in attendance.

WHEREAS, on September 17, 2018, only two (2) bidders³ submitted their bid before the 1:30 p.m. deadline and simultaneously, the BAC conducted the opening of

bids with the presence of the Technical Working Group (TWG), after evaluation of eligibility and technical components of Vistaaire Marketing and Caresystem Technology Solution Co., Inc., the BAC declared the bidder as "eligible". Thus Envelope No. 2 containing the financial proposal were opened, to wit:

WHEREAS, the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on September 25, 2018 to Caresystem Technology Solution Co., Inc. having the lowest calculated bid, after validation and verification, the TWG determined that the Caresystem Technology Solution Co., Inc. be post-disqualified for failure to satisfy all the requirements specified in the Bidding Documents (particularly in ITB Clause 29.2, Section III).

WHEREAS, In view of the post-disqualification of Caresystem Technology Solution Co., Inc., the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on October 23, 2018 to the second lowest bidder Vistaaire Marketing, after validation and verification, the TWG determined that the Vistaaire Marketing complied with the OMB technical specifications and are responsive to all the legal requirements and conditions for eligibility.

NOW, THEREFORE, the undersigned members of the Bids and Awards Committee hereby RESOLVE and RECOMMEND the award of contract to VISTAAIRE MARKETING having submitted the Lowest Calculated and Responsive Bid of \$\frac{1}{2}964,000.00\$, subject to the posting of a bond to guarantee performance.
