**RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING  
ENTITY THE PROCUREMENT OF FIVE (5) UNITS OF DESKTOP  
COMPUTERS BUNDLED WITH FIVE (5) UNITS UNINTERRUPTIBLE POWER  
SUPPLY (UPS)**

**WHEREAS**, the Office of the Ombudsman intends to procure five (5) units of Desktop Computers with Uninterruptible Power Supply (UPS) for the use of personnel of OMB-Proper;

**WHEREAS**, the Approved Budget for the Contract (ABC) for the five (5) units Of Desktop Computers Bundled with five (5) units Uninterruptible Power Supply (UPS) is **Three Hundred Twenty-Five Thousand Pesos (₱325,000.00)** (References: Purchase Requests Nos. CO-18-10-732 with 2018SPPMP154 of OMB-Proper;

**WHEREAS**, Repeat Order pertains to the procurement of goods from the previous winning bidder<sup>1</sup>, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding;

**WHEREAS**, on 11 July 2018, the Office of the Ombudsman issued a Notice to Proceed to **DCI Int'l. I.T. Solutions & Services Corporation** for the award of the contract in the project entitled Public Bidding for the Supply and Delivery of Information Technology Equipment and Peripherals for the Office of the Ombudsman under Contract Agreement No. 2018-10, with an Approved Budget for the Contract (ABC) broken down as follows:

**WHEREAS**, the procurement is urgent in order to address the immediate needs of the Ombudsman personnel of OMB-Proper;

**WHEREAS**, the requirements under Section 51 of the Government Procurement Reform Act (Republic Act No. 9184) and its Implementing Rules and Regulations have been complied with, to wit:

- a) Unit prices of the repeat order must be the same as or lower than those in the original contract: Provided, that such prices are still the most advantageous to the Government of the Philippines after price verification;

- b) The repeat order will not result in splitting of contracts, requisitions, or purchase orders, as provided for in Section 54.1 of this IRR;
- c) The repeat orders shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract: Provided, that there has been a partial delivery, inspection and acceptance of the goods within the same 6-month period; and
- d) The repeat order does not exceed twenty -five percent (25%) of the quantity of each item in the original contract. In order not to exceed the 25% threshold, the goods under the original contract must be:
  - i. Quantifiable
  - ii. Divisible; and
  - iii. Consisting of at least four (4) units per item.


**WHEREAS**, R.A. 9184 and its IRR necessitates the approval of the Head of the Procuring Entity in case there is a need to resort to any of the alternative modes for the procurement of items previously through public bidding.

**NOW, THEREFORE**, the Bids and Awards Committee resolves as it hereby resolved to recommend to the Head of the Procuring Entity, or her duly authorized representative, the procurement of five (5) units Of Desktop Computers Bundled with five (5) units Uninterruptible Power Supply (UPS) through Repeat Order under Section 51 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 or otherwise known as the Government Procurement Reform Act, with a contract price of **Three Hundred Seventeen Thousand Five Hundred Pesos**, broken down as follows:

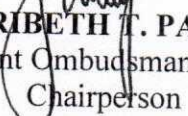

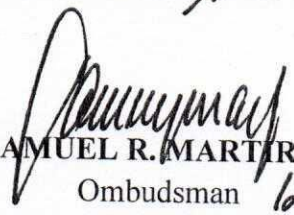
