

2. All quotations shall be valid for 45 days from the deadline of submission and considered as fixed prices and not subject to price escalation during the contract implementation.

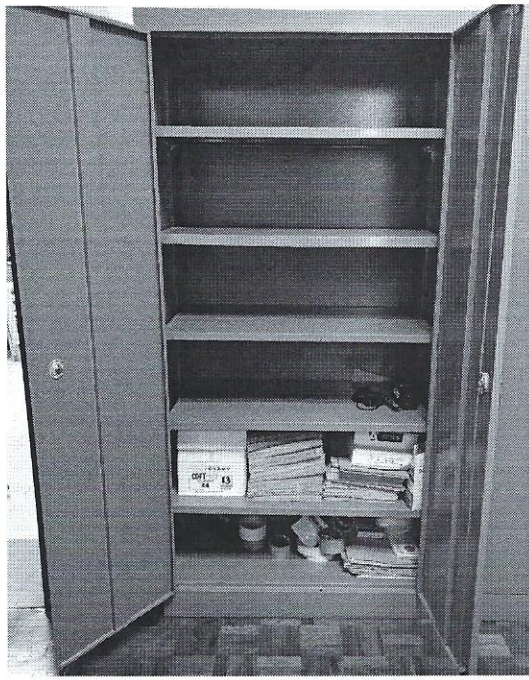
