WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Various Information and Technology (IT) Equipment and Peripherals for the Office of the Ombudsman for Lot 1 (Business Desktop Computer Sets Uninterruptible Power Supply (UPS) (PB 2018-28)** and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Three Million Four Hundred Sixty-Two Thousand Three Hundred Forty-Four Pesos and Sixty Centavos (**₱3,462,344.60**) (hereinafter called "the Contract Price"), to wit:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.




