Re: Award for PB-2018-29

**WHEREAS**, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 173 and Office Order No. 735 (Series of 2018), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

**WHEREAS**, on November 23, 2018, the Invitation to Bid for **PB 2018-29: Public Bidding for the Supply and Delivery of Five (5) units Brand New Motor Vehicles (Vans) Requirement (OSP) of the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

**WHEREAS**, the total Approved Budget for the Contract (ABC) for **PB 2018-29: Public Bidding for the Supply and Delivery of Five (5) units Brand New Motor Vehicles (Vans) Requirement (OSP) of the Office of the Ombudsman** is **Seven Million Nine Hundred Seventy-Five Thousand Pesos (Php7,975,000.00)**.

**WHEREAS**, for the period from November 23, 2018 to December 17, 2018, one (1) prospective bidder<sup>1</sup> bought the bid documents.

**WHEREAS**, a Pre-Bid Conference was conducted on December 04, 2018 at 2:30 p.m. with two (2) prospective bidders<sup>2</sup> in attendance.

**WHEREAS**, on December 17, 2018<sup>3</sup>, one (1) bidder submitted their bid before the 10:00 a.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of eligibility and technical components of **Toyota Quezon Avenue Inc.**, the BAC declared all the bidders as **"eligible"**. Thus Envelope No. 2 containing their financial proposal were opened, to wit:
