KNOWN ALL MEN BY THESE PRESENT:

This Contract is executed and entered into for all intents and in all respects at Quezon City, Philippines on this FEB day of 2019, 2019, by and between:

THE OFFICE OF THE OMBUDSMAN, with principal office address at Ombudsman Building, Agham Road, Diliman, Quezon City, represented by **HON. SAMUEL R. MARTIRES**, Ombudsman, hereinafter referred to as "the ENTITY":

TOYOTA QUEZON AVENUE INC., with business address at 728 Quezon Avenue, Quezon City, represented by **MS. DIORELLA JEAN R. ALEGATA**, Marketing Professional, hereinafter referred to as "the SUPPLIER".

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Five (5) units Brand New Motor Vehicles (VANS) Requirement (OSP) of the Office of the Ombudsman** (PB 2018-29) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Seven Million Five Hundred Twenty-Five Thousand Pesos (**₱7,525,000.00**) (hereinafter called "the Contract Price"), to wit:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- (c) the Schedule of Requirements (Annex "C");
- (d) the Technical Specifications (Annex "D");
- (e) the General Conditions of Contract (Annex "E");
- (f) the Special Conditions of Contract (Annex "F");
- (g) the Entity's Notice of Award (Annex "G"); and
- (h) the Performance Security (Annex "H")



The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

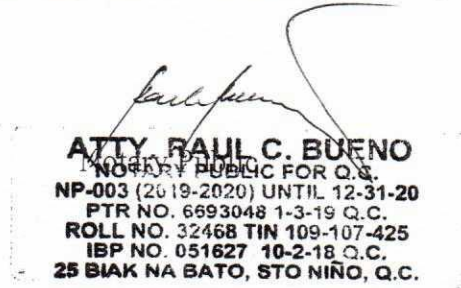
