Re: Award for PB-2018-32

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 173 and Office Order No. 735 (Series of 2018), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

WHEREAS, on November 16, 2018, the Invitation to Bid for **PB 2018-32: Rebidding of Quarterly CY 2018 General Office Supplies Requirement for the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

WHEREAS, the total Approved Budget for the Contract (ABC) for **PB 2018-32: Rebidding of Quarterly CY 2018 General Office Supplies Requirement for the Office of the Ombudsman** is **One Million Six Hundred Fifty Eight Thousand Four Hundred Pesos (Php1,658,400.00)**.

WHEREAS, for the period from November 16, 2018 to December 17, 2018, one (1) prospective bidder¹ bought the bid documents.

WHEREAS, a Pre-Bid Conference was conducted on November 28, 2018 at 2:30 p.m. with two (2) prospective bidders² in attendance.

WHEREAS, on December 17, 2018³, one (1) bidder submitted their bid before the 2:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of eligibility and technical components of **PBT Technology Solutions Inc.**, the BAC declared all the bidders as **"eligible"**. Thus Envelope No. 2 containing their financial proposal were opened, to wit:
