AMENDED NOTICE TO SELL UNSERVICEABLE VEHICLES

1. The Office of the Deputy Ombudsman for Luzon, through its Bids and Awards Committee on Disposal (BAC-Disposal), invites interested bidders/buyers to bid for UNSERVICEABLE VEHICLES on an "AS-IS-WHERE-IS" basis, as listed below:

2. Bids received lower than the floor price shall be automatically rejected.
3. The schedule for inspection of the above-mentioned vehicles will be on 04, 05, and 06 March 2019 at 1:00 pm to 3:00 pm at the Finance and Administration Bureau, Office of the Deputy Ombudsman for Luzon, 3rd Floor Main Building, Agham Road, Diliman, Quezon City.
4. Pursuant to item 5.5.1, Constitutional Fiscal Autonomy Group (CFAG) Joint Resolution No. 35, members of the Bids and Awards Committee and the Disposal Committee and their relatives within the fourth civil degree of consanguinity or affinity, are not allowed to participate in this bidding.
5. Bidding documents may be purchased by interested bidders from the address given above and upon payment of a non-refundable fee of Two Hundred Pesos (Php200), starting on March 04, 2019 until March 18, 2019 at 12:00 noon.
6. Only one sealed quotation per lot shall be submitted in a big envelope with separate envelopes inside for: 1) Bid price envelope and 2) Bidding requirements envelope. These envelopes will be provided.

For Individual bidders:

1. Current Residence Certificate or any valid government-issued identification card
2. Tax Identification Number
3. Income Tax Returns for CY 2018 or BIR form 2316 (Certificate of compensation payment/Tax withheld)
4. 10% Bidder's bond computed based on the bid price submitted in the form of manager's/cashier's check or cash.

1. Valid Mayor's Permit where the principal office is located
 2. Income Tax Returns for CY 2018
 3. 10% Bidder's bond computed based on the bid price submitted in the form of manager's/cashier's check or cash.
7. The sealed quotation to be submitted indicate the particular lot on the face of the big envelope. Addressed to the BAC-Disposal Chairperson and shall include the requirements mentioned above.
8. Where the bidder intends to buy more than one service vehicle, the bidder shall purchase the bidding documents per lot, and shall submit separate sealed quotation per lot.

11. Winning bidders should pay the full bid price within five (5) working days from the receipt of a Notice of Award, otherwise, the bid will be awarded to the next highest bidder.
