**BAC DECISION NO. 14-2-2019**

**WHEREAS**, there is an approved Purchase Request (PR) No. 19-01-010 dated 6 February 2019 with an estimated cost of One Hundred Twenty-Two Thousand Two Hundred Seventy-Two Pesos (₱122,272.00) to purchase various janitorial supplies for the maintenance of Ombudsman Mindanao Office.

**WHEREAS**, under BAC Resolution No. 14, series of 2019, dated 6<sup>th</sup> day of February 2019, which was approved by the Head of the Procuring entity, the BAC recommended to resort to Shopping Ordinary/Regular Office Supplies (Section 52.1) in procuring the items in PR No. 19-01-010.

**WHEREAS**, the BAC, thru its Secretariat, distributed the Invitations or Requests for Submission of Price Quotations to suppliers on the said PR and had obtained four (4) price quotations from credible suppliers namely:

- 3.) **ECV OFFICE SUPPLIES WAREHOUSE, INC.**
- 4.) **PRINCE EDUCATIONAL SUPPLY**
