WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **One (1) Year License Subscription and Technical Support for the Ombudsman-Wide Connectivity of the Office of the Ombudsman** (PB 2019-03) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Two Million Four Hundred Eight Thousand Pesos (**₱2,408,000.00**) (hereinafter called "the Contract Price"), to wit:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.







2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) the Financial Proposals (Annex "A");

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
