This Contract is executed and entered into for all intents and in all respects at Quezon City, Philippines on this 26 day of April, 2019, by and between:

WITNESSETH

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract




