BAC Resolution No. 09-2019 (PB)
Series of 2019

Re: Award for PB-2019-01

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

WHEREAS, on March 06, 2019, the Invitation to Bid for **PB 2019-01: Public Bidding of One (1) Year Janitorial, Maintenance and Other Services Requirement (127 Personnel including Supplies and Materials) for the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

WHEREAS, the total Approved Budget for the Contract (ABC) **PB 2019-01: Public Bidding of One (1) Year Janitorial, Maintenance and Other Services Requirement (127 Personnel including Supplies and Materials) for the Office of the Ombudsman** is **Thirty Three Million One Hundred Sixty Six Thousand Nine Hundred Forty Eight Pesos and Sixty Four Centavos (Php33,166,948.64)**.

WHEREAS, for the period from March 06, 2019 to April 02, 2019, two (2) prospective bidders¹ bought the bid documents.

WHEREAS, a Pre-Bid Conference was conducted on March 21, 2019 at 1:30 p.m. with four (4) prospective bidders² in attendance.

WHEREAS, on April 02, 2019, two (2) bidders³ submitted their bid before the 2:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of their eligibility and technical components of **CBII Philippines Int'l Inc. and Philcare Manpower Services**,

the BAC declared all the bidders as “eligible”. Thus Envelope No. 2 containing the financial proposal of Philcare Manpower Services were opened, to wit:

2) Philcare Manpower Services	₱31,308,833.28

WHEREAS, on April 24, 2019, the BAC through TWG conducted detailed bid evaluation pursuant to Section 32, RA 9184 (Government Procurement Reform Act), using a non-discretionary criteria in considering the following (a) completeness of the bid; and (b) arithmetical correction. After evaluation, CBII Philippines International Inc. (CBII) failed to submit valid Mayor’s /Business Permit and Tax Clearance during the opening of bids which under the rules is considered as insufficient compliance. Hence, **CBII was disqualified⁴**.

WHEREAS, after evaluation of the bid submitted by Philcare Manpower, the TWG noticed some discrepancies on the computation of its submitted financial proposal, after clarification and correction of computational errors, the TWG recommended the calculated bid⁵ of Philcare Manpower Services be corrected as follows:

WHEREAS, the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on May 21, 2019, to **Philcare Manpower Services** (having the Single Calculated Bid). After validation and verification⁶, the TWG determined that Philcare Manpower Services complied with the OMB technical specifications and is responsive to all the legal requirements and conditions for eligibility.
