Re: Award for PB-2019-02

**WHEREAS**, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

**WHEREAS**, on March 05, 2019, the Invitation to Bid for **PB 2019-02: Public Bidding for the Supply and Delivery of One (1) unit Brand New Motor Vehicle Requirement (VAN) of the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

**WHEREAS**, the total Approved Budget for the Contract (ABC) **PB 2019-02: Public Bidding for the Supply and Delivery of One (1) unit Brand New Motor Vehicle Requirement (VAN) of the Office of the Ombudsman** is **Three Million One Hundred Thousand Pesos (Php3,100,000.00)**.

**WHEREAS**, for the period from March 05, 2019 to April 02, 2019, one (1) prospective bidder<sup>1</sup> bought the bid documents.

**WHEREAS**, a Pre-Bid Conference was conducted on March 19, 2019 at 2:30 p.m. with one (1) prospective bidder<sup>2</sup> in attendance.

**WHEREAS**, on April 02, 2019<sup>3</sup>, one (1) bidder submitted their bid before the 2:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of eligibility and technical components of **Areza Motor Sales**, the BAC declared all the bidders as "**eligible**". Thus Envelope No. 2 containing their financial proposal were opened, to wit:




