Re: Award for PB-2019-03

**WHEREAS**, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

**WHEREAS**, on May 16, 2019, the Invitation to Bid for **PB 2019-03: Public Bidding of (1) One Year License Subscription and Technical Support for Ombudsman-Wide Connectivity of the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

**WHEREAS**, the total Approved Budget for the Contract (ABC) **PB 2019-03: Public Bidding of (1) One Year License Subscription and Technical Support for Ombudsman-Wide Connectivity of the Office of the Ombudsman** is **Two Million Five Hundred Ninety Thousand Pesos (PhP2,590,000.00)**.

**WHEREAS**, for the period from May 16, 2019 to June 07, 2019, one (1) prospective bidder<sup>1</sup> bought the bid documents.

**WHEREAS**, a Pre-Bid Conference was conducted on May 24, 2019 at 1:30 p.m. with one (1) prospective bidder<sup>2</sup> in attendance.

**WHEREAS**, on June 07, 2019<sup>3</sup>, one (1) bidder submitted their bid before the 1:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of eligibility and technical components of **Microgenesis Software, Inc. doing business under the name and style of Microgenesis Business Systems**, the BAC declared the bidder as "**eligible**". Thus Envelope No. 2 containing their financial proposal were opened, to wit:


The dispositive portion reads as follows:




