Re: Award for PB-2019-06

**WHEREAS**, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

**WHEREAS**, on February 27, 2019 the Invitation to Bid for **PB 2019-06: Public Bidding for the Supply, Delivery and Installation of Modular Partitions including its Accessories and Furniture and Fixtures for the Various Offices of the Office of the Ombudsman**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

**WHEREAS**, the total Approved Budget for the Contract (ABC) for **PB 2019-06: Public Bidding for the Supply, Delivery and Installation of Modular Partitions including its Accessories and Furniture and Fixtures for the Various Offices of the Office of the Ombudsman** is **Two Million Five Hundred Five Thousand Pesos (₱2,505,000.00)**, categorized as follows:

**WHEREAS**, for the period from February 27, 2019 to March 22, 2019, five (5) prospective bidders<sup>1</sup> bought the bid documents.

**WHEREAS**, a Pre-Bid Conference was conducted on March 07, 2019 at 1:30 p.m. with seven (7) prospective bidders<sup>2</sup> in attendance.

**WHEREAS**, on March 22, 2019, four (4) bidders<sup>3</sup> submitted their bid before the 1:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of their eligibility and technical components, the BAC declared the four (4) bidders namely: **Design Excellence Home & Office System, Distinctive Blinds & Office Systems, Inc., Asahi Design Centre Inc. and JECAMS Inc.** as “eligible”. Thus Envelope No. 2 containing the financial proposals of Design Excellence Home & Office System, Distinctive Blinds and Office Systems, Inc., Asahi Design Centre Inc. and JECAMS Inc., were opened, to wit:

After validation and verification, the TWG determined that the Asahi Design Centre Inc. and Distinctive Blinds & Office Systems, Inc. complied with the OMB technical specifications and are responsive to all the legal requirements and conditions for eligibility.


