## Re: Award for PB-2019-14

WHEREAS, on 03 June 2019<sup>3</sup>, one (1) bidder submitted their bid before the 1:30 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of eligibility and technical components of Otus Copy Systems, Inc., the BAC declared the bidder as "eligible".
