**RESOLUTION NO. AMP-10-097**  
**AWARD FOR QN 2019-0090-AUG**

**WHEREAS**, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts awarded pursuant to the provisions of Republic Act 9184 and its Revised Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

**WHEREAS**, there is an approved **Purchase Request (PR) No. CO-19-04-235** with an Approved Budget for the Contract (ABC) of **One Million Two Hundred Eighty Thousand Pesos (₱ 1,280,000.00)** for the **Negotiated Procurement for the Supply and Delivery of Two (2) units Air Circuit Breaker (4,000 AT)** for the Office of the Ombudsman for the use of **CAS GSD-BA**;

**WHEREAS**, said item is included in the **Annual Procurement Plan for 2019 (APP Code: 2019APP121)**;

**WHEREAS**, the Bids and Awards Committee was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of **Section 53.1** of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (**Two Failed Biddings**) per approved Technical Working Group (TWG) Memorandum dated **31 May 2019**;

**WHEREAS**, the BAC has undertaken the following activities:

- 1) Posted **Invitation to Bid** for **QN 2019-0090-AUG (1<sup>st</sup> negotiation)** at the PhilGEPS (Reference No. 6378590), Ombudsman Website and BAC Bulletin Board on **07 August 2019** and set the Negotiation Conference on **13 August 2019, 1:30 p.m.** and deadline of submission of bids on **20 August 2019, 1:30 p.m.**;
- 2) Issued **Supplemental / Bid Bulletin No. 1** dated **09 August 2019** for the **Postponement** and setting of **New Schedule of the Negotiation Conference** on **15 August 2019, 10:00 a.m.**;
- 3) Requested quotations from **six (6)** suppliers of known qualifications;
  - a) A.G. DATACOM PHILIPPINES, INC.;
  - b) NEXUS ELECTRICAL NETWORK SOLUTIONS;
  - c) INNOVALITE ELECTRICAL ENTERPRISES;
  - d) PRIMEGOODS TRADING & ELECTRICAL SUPPLY COMPANY;
  - e) AVESCO MARKETING CORPORATION; and
  - f) CAPTURED ENERGY GREEN SOLUTIONS, INC.

- 4) Conducted a **Negotiation Conference** on **15 August 2019** with **three (3)** prospective bidders in attendance;
- 5) Issued **Supplemental / Bid Bulletin No. 2** dated **16 August 2019** for the **Postponement of the Schedule of Submission of Best and Final Offer and Opening of Bids until Further Notice**;
- 6) Issued **Supplemental / Bid Bulletin No. 3** dated **06 September 2019** for the **Amendments to the Bidding Documents and New Schedules for Ocular Inspection and Opening of Bids** was set on **11 September 2019, 10:00 a.m.** and **18 September 2019, 1:30 p.m.**, respectively;

Upon the recommendation of the TWG and BAC and with the approval of the Head of the Procuring Entity, the project title was amended to as **“Negotiated Procurement for the Supply, Delivery and Installation of Two (2) Units Air Circuit Breaker (4,000 AT) for the Office of the Ombudsman Annex Building”**

- 7) Conducted an **Ocular Inspection** on **11 September 2019** with **three (3)** prospective bidders in attendance;
- 8) Received **two (2)** price quotations from the following suppliers before the 1:30 p.m. deadline on 18 September 2019:
  - a) A.G. DATACOM PHILIPPINES, INC.; and
  - b) CP PARLAY INTERNATIONAL CORPORATION

**WHEREAS**, the Opening of Bids was conducted on 18 September 2019, 1:30 p.m., wherein both bidders, **A.G. DATACOM PHILIPPINES, INC.** and **CP PARLAY INTERNATIONAL CORPORATION**, were declared as “Eligible”. Thereafter, the Financial Proposals were opened and revealed the following bids, to wit:

**WHEREAS**, the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on 26 September 2019 to **CP PARLAY INTERNATIONAL CORPORATION**. After validation and verification, the TWG determined that **CP PARLAY INTERNATIONAL CORPORATION** complied with OMB technical specifications and is responsive to all the legal requirements and conditions for eligibility.

**WHEREAS**, the BAC, upon recommendation from the TWG and upon due deliberation of the submitted bid, found the offer of **CP PARLAY INTERNATIONAL CORPORATION** as the Lowest Calculated Bid detailed as follows:


