INVITATION TO BID
"PUBLIC BIDDING FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING
AND COMMISSIONING OF FOUR (4) UNITS BRAND NEW ELEVATORS OF THE
OFFICE OF THE OMBUDSMAN MAIN BUILDING"

1. The Office of the Ombudsman, through the General Appropriations Act of 2019 intends to apply the sum of **Twelve Million Pesos (P12,000,000.00)**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply, Delivery, Installation, Testing and Commissioning of Four (4) Units Brand New Elevators of the Office of the Ombudsman Main Building (SBAC-PB-2019-01)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Office of the Ombudsman now invites bids for the **Public Bidding for the Supply, Delivery, Installation, Testing and Commissioning of Four (4) Units Brand New Elevators of the Office of the Ombudsman Main Building**. Completion of the works is required within **one hundred ninety (190) calendars days** from receipt of Notice to Proceed. **Bidders should have completed within five (5) years prior to the date of submission and receipt of bids, a contract similar to the Project**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, corporations or other business organizations with at least **sixty percent (60%)** interest or outstanding capital stock belonging to citizens of the Philippines. (*Reference: GPPB Resolution No. 06-2019 dated 08 March 2019*)

4. Interested bidders may obtain further information from the Special Bids and Awards Committee (SBAC) Secretariat, 3rd Floor, PIAB-D, Ombudsman Annex Building, Agham Road, Diliman, Quezon City and inspect the Bidding Documents from Monday to Friday, 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders from November 15, 2019 to December 09, 2019, from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Twenty Five Thousand Pesos (P25,000.00).

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS). However, the Bidders with the downloaded bidding documents are required to pay the non-refundable fee not later than the submission of their bids.
7. The Office of the Ombudsman will hold a Pre-Bid Conference on **November 22, 2019 at 10:00 a.m.**, at the Hearing Room, Ground Floor, Ombudsman Main Building, Agham Road, Quezon City which shall be open to all interested parties.
8. Bids must be delivered to the **SBAC Secretariat, 3rd Floor, PIAB-D, Ombudsman Annex Building, Agham Road, Quezon City on or before 1:30 p.m. of December 09, 2019.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18. Late bids shall not be accepted
9. Bid opening shall be on December 09, 2019 at 1:30 p.m. at the Hearing Room, Ground Floor, Ombudsman Main Building, Agham Road, Quezon City, in the presence of the Bidders or their duly authorized representatives.
