## WITNESSETH

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Supply, Delivery and Installation of Two (2) units Air Circuit Breaker (4,000AT) for the Office of the Ombudsman Annex Building (QN-2019-0090-AUG)**, through Negotiated Procurement under Section 53.1 of RA 9184 and its IRR, and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Eight Hundred Ninety-Six Thousand Pesos (**₱896,000.00**) (hereinafter called "the Contract Price"), to wit:

- (d) the Supplier's Performance Bond (Annex "D").


