WHEREAS, there is an approved Purchase Request (PR) No. 19-10-142 dated 11 October 2019, with an estimated cost of Four Hundred Ninety-Two Thousand Pesos (₱492,000.00) to acquire courier service provider for Ombudsman – Mindanao documents to be sent to OMB – Central Office and to other government offices for the year 2020. Current service provider contract will end on December 31, 2019.

WHEREAS, under BAC Resolution No. 108, series of 2019, dated 15th day of October 2019, which was approved by the Head of the Procuring entity, the BAC recommended to resort to Small Value Procurement (Section 53.9) in procuring the items stated in PR No. 19-10-142.

WHEREAS, the BAC, thru its Secretariat, distributed the Invitations or Requests for Submission of Price Quotations to suppliers on the said Purchase Request and had obtained four (4) price quotations from credible suppliers namely:

- 3.) **JRS BUSINESS CORPORATION**
- 4.) **JRS EXPRESS**

WHEREAS, the BAC, after due deliberation of the received Request for Quotation from the suppliers find that the price offered by **LIBCAP SUPER EXPRESS CORPORATION** is most advantageous to the government for the annual courier service stated below:
