This Contract is executed and entered into for all intents and in all respects at Quezon City, Philippines on this NOV 27 2019, 2019, by and between **MANILA**

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Quarterly CY 2019 General Office Supplies Requirement of the Office of the Ombudsman for Lot 1** (PB 2019-18) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Four Hundred Twenty-Seven Thousand Four Hundred Twelve Pesos and Fifty Centavos (**₱427,412.50**) (hereinafter called "the Contract Price"), to wit:

- (h) the Performance Security (Annex "H")






