This Contract is executed and entered into for all intents and in all respects at Quezon City, Philippines on this NOV 20 day of 2019 2019, by and between:

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Quarterly CY 2019 General Office Supplies Requirement of the Office of the Ombudsman for Lot 2** (PB 2019-18) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of Six Hundred Fifty-Eight Thousand Two Hundred Pesos (**₱658,200.00**) (hereinafter called "the Contract Price"), to wit:

- (e) the General Conditions of Contract (Annex "E");
- (f) the Special Conditions of Contract (Annex "F");
- (g) the Entity's Notice of Award (Annex "G"); and
- (h) the Performance Security (Annex "H")




