
WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Annual Maintenance and Support (AMS) for ManageEngine Products for the Office of the Ombudsman** (PB 2019-20-Rebidding) and has accepted a bid by the Supplier for the supply of those goods and services in the sum of One Million Seven Hundred Forty-Six Thousand Four Hundred Twenty-Four Pesos and Fifty-Three Centavos (**₱1,746,424.53**) (hereinafter called "the Contract Price"), to wit:

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) the Financial Proposals (Annex "A");

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




