INVITATION TO BID
"PUBLIC BIDDING FOR ONE (1) YEAR DAILY SUPPLY OF
PURIFIED DRINKING WATER WITH DISPENSERS
FOR THE OFFICE OF THE OMBUDSMAN"

1. The Office of the Ombudsman through the General Appropriations Act for CY 2020 intends to apply the sum of **One Million One Hundred Ninety Three Thousand Two Hundred Eighty Pesos (Php1,193,280.00)**, being the Approved Budget for the Contract (ABC) to payments of the procurement of the **One (1) Year Daily Supply of Purified Drinking Water with Dispensers for the Office of the Ombudsman (PB 2020-03)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Office of the Ombudsman now invites bids for the **Public Bidding for One (1) Year Daily Supply of Purified Drinking Water with Dispensers for the Office of the Ombudsman**. Delivery of goods on daily basis is required for **one (1) year which shall commence on the following day after receipt of the Notice to Proceed**. Bidders should have completed a contract similar to the Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183. Interested bidders should be enrolled in the Electronic Filing and Payment System (eFPS) program of the Bureau of Internal Revenue (BIR), pursuant to Executive Order No. 398, RR 3-2005, and must be registered under the Philippine Government Electronic Procurement System (PhilGEPS).

4. Interested bidders may obtain further information from the Office of the Ombudsman and inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting February 04, 2020 to February 27, 2020, from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of Five Thousand Pesos (P 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and Office of the Ombudsman, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Office of the Ombudsman will hold a Pre-Bid Conference on **February 12, 2020 at 1:30 p.m.** at the OMB Hearing Room, Ground Floor, Ombudsman Main Building, Agham Road, Quezon City which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before **February 27, 2020, 1:30 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on February 27, 2020, 1:30 p.m. at the OMB Hearing Room, Ground Floor, Ombudsman Main Building, Agham Road, Quezon City. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address stated below. Late bids shall not be accepted.
