This Contract is executed and entered into for all intents and in all respects at Quezon City, Philippines on this **FEB 12 2020** day of _____, 2019, by and between:

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Various Information Technology (IT) Equipment and Peripherals for the Office of the Ombudsman (PB 2019-27)** and has accepted a bid by the Supplier for the supply of those goods and services in the sum of One Hundred Seven Thousand Eight Hundred Pesos (**₱107, 800.00**) (hereinafter called "the Contract Price"), to wit:

- (h) the Performance Security (Annex "H")


