Re: Award for PB-2019-29

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications.

WHEREAS, on 28 November 2019 the Invitation to Bid for PB 2019-29: Rebidding for the Supply and Delivery of Various Information Technology (IT) Equipment and Peripherals for the Office of the Ombudsman for Lot 3 - Scanner, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

WHEREAS, the total Approved Budget for the Contract (ABC) PB 2019-29: Rebidding for the Supply and Delivery of Various Information Technology (IT) Equipment and Peripherals for the Office of the Ombudsman for Lot 3 - Scanner is Seven Hundred Fifty Thousand Pesos (\$\textstyle{2750,000.00}\$).

WHEREAS, for the period from 28 November 2019 to 19 December 2019, one (1) prospective bidder¹ bought the bid documents.

WHEREAS, on 19 December 2019, one (1) bidder submitted their bid before the 2:00 p.m. deadline and simultaneously, the BAC conducted the opening of bids with the presence of the Technical Working Group (TWG), after evaluation of eligibility and technical components of American Technologies Inc., the BAC declared the bidder as "eligible". Thus Envelope No. 2 containing their financial proposal was opened, to wit:
