## BIDS AND AWARDS COMMITTEE RESOLUTION NO. AMP-03-015 AWARD FOR QN 2020-0008-FEB

WHEREAS, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts awarded pursuant to the provisions of Republic Act 9184 and its Revised Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, there is an approved Purchase Request (PR) No. CO-20-01-010 with an Approved Budget for the Contract (ABC) of Nine Hundred Forty Five Thousand Eight Hundred Forty Pesos (P 945,840.00) for the Negotiated Procurement for the Supply and Delivery of Various Information Technology (IT) Equipment and Peripherals for the Office of the Ombudsman For Lot 1 – Business Workstation Computer sets with UPS for the use of MISS SDD;

WHEREAS, said item is included in the Annual Procurement Plan for 2020 (APP Code: 2020APP137);

WHEREAS, the Bids and Awards Committee was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (Two Failed Biddings) under the same specifications but with adjusted ABC per approved Technical Working Group (TWG) Memorandum dated 27 November 2019;

## WHEREAS, the BAC has undertaken the following activities:

- Posted Invitation to Bid for QN 2020-0008-FEB (1<sup>st</sup> negotiation) at the PhilGEPS (Reference No. 6854340), Ombudsman Website and BAC Bulletin Board on 11 February 2020 and set the Negotiation Conference on 17 February 2020, 2:30 p.m. and deadline of submission of bids on 21 February 2020, 1:30 p.m.;
- 2) Requested quotations from four (4) suppliers of known qualifications;
  - a) AMERICAN TECHNOLOGIES, INC.;
  - b) QUARTZ BUSINESS PRODUCTS CORPORATION;
  - c) ADVANCE SOLUTIONS, INC.; and
  - d) MICROGENESIS SOFTWARE, INC. doing business under the name and style of MICROGENESIS BUSINESS SYSTEMS
