With the presence of the Chairperson and five (5) Members of the Bids and Awards Committee (BAC) and the Chairperson and four (4) Members of the Technical Working Group (TWG), a quorum to transact business was manifested by the Head of the BAC Secretariat.

The Pre-Bid Conference was called to order by the BAC Chairperson. However, upon the recommendation of the TWG Chairperson, the BAC unanimously agreed to dispense with the discussion of the Invitation to Bid and other bidding requirements due to the absence of prospective bidders.

The TWG Chairperson then recommended to reduce the retention money from 5% to 1%. The BAC Chairperson then noted such recommendation and informed the TWG Chairperson that if the BAC resolves to reduce the retention money to 1%, a Supplemental / Bid Bulletin will be issued.

There being no more further matters for discussion, the Pre-Bid Conference for the Public Bidding for the Supply and Delivery of Brand New Motor Vehicles (2 units AUV) Requirement of the Office of the Ombudsman (PB 2020-02) was adjourned at 2:23 P.M.
