WHEREAS, for the period from 15 October 2020 to 03 November 2020, one (1) prospective bidder¹ bought the bid documents.

WHEREAS, a Pre-Bid Conference was conducted thru online via Microsoft Teams app on 04 September 2020 at 1:30 p.m. with seven (7) prospective bidders² in attendance.
