**BAC Resolution No. 07-2020 (PB)**  
**Series of 2020**

Re: Award for PB-2020-01

**WHEREAS**, the Bids and Awards Committee (BAC) was created pursuant to Office Order No. 219 (Series of 2019), ensuring transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing that contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications. While the terms of the undersigned Bids and Awards Committee (BAC) membership expired on 05 April 2020 (pursuant to Office Order No. 219 series of 2019), it is provided under Section 11.2.6 of the Revised Implementing Rules of RA 9184 that upon expiration of the terms of the current BAC membership they shall continue to exercise their function in the hold-over capacity until new BAC members shall have been designated.

**WHEREAS**, on 06 October 2020 the Invitation to Bid for **PB 2020-01: Public Bidding for the Security Services Requirement of the Office of the Ombudsman for Three (3) Years**, was posted at PhilGEPS, Office of the Ombudsman Website, as well as in the Agency's Bulletin Board.

**WHEREAS**, the total Approved Budget for the Contract (ABC) **PB 2020-01: Public Bidding for the Security Services Requirement of the Office of the Ombudsman for Three (3) Years** is **Forty-Two Million Three Hundred Seventy-Four Thousand Eighty-Four Pesos (PhP42,374,084.00) (for one (1) year only)**.

**WHEREAS**, for the period from 06 October 2020 to 26 October 2020, two (2) prospective bidders<sup>1</sup> bought the bid documents.

**WHEREAS**, a Pre-Bid Conference was conducted thru online via Microsoft Teams app on 14 October 2020 at 1:30 p.m. with three (3) prospective bidders<sup>2</sup> in attendance.

**WHEREAS**, on 26 October 2020, two (2) bidders<sup>3</sup> submitted their bid before the 12:00 p.m. deadline and simultaneously, the BAC conducted the opening of bids on 28 October 2020 with the presence of the Technical Working Group (TWG), after evaluation of their eligibility and technical components, the BAC declared the **Lifeguard Archangels Security Agency Corp.** as "**eligible**", while **MISG Security Agency Inc.**, was declared as "**ineligible**". Thus Envelope No. 2 containing the financial proposals of Lifeguard Archangels Security Agency Corp. was opened, to wit:

**WHEREAS**, on July 30, 2018, after the TWG conducted a detailed evaluation of bids for arithmetical computation, it has resulted that there is a decreased on the submitted bid of Lifeguard Archangels Security Agency Corp. which is lower than its submitted bid, to wit:

**WHEREAS**, the TWG conducted the necessary post-qualification proceedings pursuant to Notice of Post Qualification issued by the BAC on 04 November 2020 to **Lifeguard Archangels Security Agency Corp.** (having the Single Calculated Bid). After validation and verification<sup>4</sup>, the TWG determined that Lifeguard Archangels Security Agency Corp. complied with the OMB technical specifications and is responsive to all the legal requirements and conditions for eligibility.

**NOW, THEREFORE**, the undersigned members of the Bids and Awards Committee hereby **RESOLVE** and **RECOMMEND** the **award of contract** to **Lifeguard Archangels Security Agency Corp.**, having submitted the **Single Calculated and Responsive Bid** of **₱38,291,252.64**, subject to the posting of a bond to guarantee performance.


