**AMENDMENTS TO THE BIDDING DOCUMENTS,
 CANCELLATION OF THE PROCUREMENT FOR LOT 1 AND
 LIFTING OF SUSPENSION OF BIDDING FOR LOT 2**

- All prospective bidders are hereby informed that per Memorandum of the end-user dated 20 October 2022, the procurement of **Lot 1: Enterprise Back-up System in PB 2022-2-04** with a corresponding **Approved Budget for the Contract (ABC)** of **₱11,000,000.00** is **CANCELLED**. Thus, any reference to the procurement of the said lot in the Bidding Documents is rendered null or ineffective by virtue of this Supplemental/Bid Bulletin (SBB).
- All letters of clarification submitted by prospective bidders¹ pertaining to Lot 1 are **duly noted** considering issues presented therein are deemed moot and academic.
- Following the cancellation of **Lot 1**² and **Lot 3**,³ the title of this procurement project is hereby renamed as **PB 2022-2-04: Public Bidding for the Annual Subscription for the Redhat Operating System**, with only one (1) lot for procurement (Lot 2) and a corresponding ABC of **₱2,101,515.00**.
