

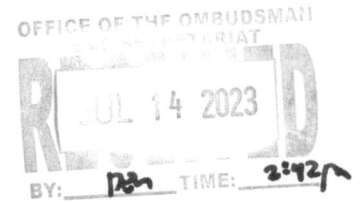

**RE: AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF THREE (3)
UNITS BRAND NEW MINI BUS FOR THE OFFICE OF THE OMBUDSMAN
(PB 2023-01)**

WHEREAS, the Office of the Ombudsman has programmed and approved Purchase Request (PR) No. PU-23-02-008 for the procurement of Vehicle – Mini-Bus (APP Code: 2023APP-093)¹ for the use of General Administration Office (GAO) with a total Approved Budget for the Contract (ABC) of Fourteen Million Four Hundred Thousand Pesos (PhP14,400,000.00);

WHEREAS, the Bids and Awards Committee – Main (BAC-Main), in an approved Memorandum dated 08 February 2023, was authorized to conduct its procurement through public bidding in accordance with the Updated 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, the BAC-Main constituted a Technical Working Group (TWG) to assist in the preparation/determination of the appropriate specifications and eligibility requirements for the said procurement project;²

WHEREAS, a Pre-Procurement Conference was conducted on 13 March 2023 through videoconferencing with the Chairperson and Members of the BAC-Main, Chairperson and Members of the TWG, and the BAC Secretariat in attendance;

WHEREAS, upon the recommendation of the BAC-Main and the TWG, the Head of the Procuring Entity (HoPE) approved the technical specifications and total ABC of this procurement;

WHEREAS, the Invitation to Bid (ITB) for the Public Bidding for the Supply and Delivery of Three (3) Units Brand New Mini Bus for the Office of the Ombudsman (PB 2023-01) was posted at the PhilGEPS and Office of the Ombudsman (OMB) websites, and BAC Bulletin Board on 28 April 2023;

WHEREAS, Letters of Invitation for the Pre-Bid Conference, Opening of Bids, Bid Evaluation and Post-Qualification were sent to and received by:

- b. AO Pilarita T. Lapitan (Assistant Ombudsman, OMB-Proper);

- d. Mr. Paterno Menzon (Co-Chairman, Coalition Against Corruption – Bishops Business Conference – Laiko (Government Procurement Monitoring Committee);
- e. Ms. Teresita S. Miguel (Supervising Auditor, COA); and
- f. Mr. Nolasco B. Ducay (President, OMBEA);

WHEREAS, a Pre-Bid Conference³ was conducted online via Microsoft Teams Application on 11 May 2023 with the BAC-Main, TWG, BAC Secretariat, witnesses/observers, and six (6) prospective bidders in attendance;

WHEREAS, on 16 May 2023, Supplemental/Bid Bulletin No. 1 amending the Bidding Documents/Invitation to Bid was issued and posted at the PhilGEPS and OMB websites, and BAC Bulletin Board;

WHEREAS, three (3) bidders purchased and submitted their bidding documents before the 02:00 p.m. deadline on 23 May 2023;

WHEREAS, the Opening of Bids⁴ was conducted on 24 May 2023 at 01:30 p.m., with the BAC-Main, bidders and observers attending via MS Teams Application, and with the BAC Secretariat and TWG in physical attendance;

WHEREAS, after the conduct of eligibility check and evaluation of the submitted bids,⁵ the BAC-Main, upon the recommendation of the TWG, rated GOLDEN ASIA AUTOMOTIVE BUILDER, INC. (GOLDEN ASIA), AREZA MOTOR SALES (AREZA), and GENESIS AUTO CORPORATION (GENESIS) as "PASSED" in all their eligibility requirements and declared them as "ELIGIBLE" to participate further in the opening of bids;

WHEREAS, on 29 May 2023, a Bid Evaluation⁶ was conducted to further evaluate the completeness of the bids and arithmetical calculations of the submitted Financial Components (Envelope No. 2) of the eligible bidders, the result of which is as follows:

WHEREAS, on 29 May 2023, a Notice of Post Qualification was sent to GENESIS, requiring it to submit/present on 05 June 2023 the original copies and certified true copies of the required documents to the TWG/BAC during the post-qualification proceedings. Witnesses and observers were likewise invited to attend the said activity;

WHEREAS, after validation, verification and determination during the post-qualification proceeding conducted on 05 June 2023 on GENESIS,⁷ the TWG found that it had satisfactorily presented the documents required, complied with the Office's technical specifications and was responsive to all the legal requirements and conditions for eligibility; hence, the TWG recommended the award of contract to the said supplier;






