Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of THIRTY-SIX MILLION FORTY-NINE THOUSAND FIVE HUNDRED NINETY-TWO PESOS AND FIFTY TWO CENTAVOS (\$\Partial{P}36,049,592.52\$) or such other sums as may be ascertained, PHILCARE MANPOWER SERVICES agrees to the One (1) Year Janitorial, Maintenance and Other Services Requirement (including Supplies and Materials) for the Office of the Ombudsman in accordance with its Bid.
