BAC DECISION NO. 42-10-2023

WHEREAS, there is an approved Purchase Request (PR) No. 23-09-0117, dated 27 September 2023, by Deputy Ombudsman for Mindanao Anderson A. Lo with an estimated budget cost of Seventy-Seven Thousand Three Hundred Seventy-Five Pesos (₱77,375.00) for the procurement of various electrical supplies for the Office of the Deputy Ombudsman for Mindanao use.

WHEREAS, under BAC Resolution No. 66, series of 2023, dated 27th of September 2023, which was approved by the Head of the Procuring entity, the BAC recommended to resort to SHOPPING-Ordinary/Regular Office Supplies (Section 52.1.(b)) in procuring the various electrical supplies as stated in PR No. 23-09-0117 dated 27 September 2023.

WHEREAS, the BAC, thru its Secretariat, distributed the Invitations or Requests for Submission of Price Quotations to the suppliers of the said items and had obtained four (4) price quotations from credible suppliers namely:

- 1.) **E-LIGHT ELECTRICAL LIGHTINGS & SUPPLIES**
- 2.) **CITI HARDWARE MATINA**
- 3.) **CARE SYSTEM TECHNOLOGY SOLUTION CO. INC.**
- 4.) **JLY STEEL BUILDERS CORP.**

WHEREAS, the BAC, after due deliberation of the received Request for Quotation from the suppliers finds that **E-LIGHT ELECTRICAL LIGHTINGS & SUPPLIES** offered the lowest quoted price but cannot comply the PhilGEPS Registration Certificate for they are not PhilGEPS registered. **JLY STEEL BUILDERS CORP.** quoted the second lowest price and compliant to the documents required by the government, which is most advantageous to the government for the procurement of the items stated below:




