WHEREAS, there is an approved Purchase Request (PR) No. 23-09-0118, dated 28 September 2023, by Deputy Ombudsman for Mindanao Anderson A. Lo with an estimated budget cost of One Hundred Three Thousand Pesos (₱103,000.00) for the procurement of labor and materials for the general cleaning and replacement of Compressor Assy. of Mini Bus (Coaster) SAB-6795 Airconditioning Unit, of the Office of the Deputy Ombudsman for Mindanao, Davao City.


