WHEREAS, there is an approved Purchase Request (PR) No. 23-10-0125, dated 12 October 2023, by the Deputy Ombudsman for Mindanao Anderson A. Lo with an estimated budget cost of Ten Thousand Pesos (₱10,000.00) for the procurement of one (1) unit Ladder for the Preliminary Investigation, Administrative Adjudication and Prosecution Bureau-A (PIAAPB-A) of OMB-Min Office.

WHEREAS, the BAC, after due deliberation of the received Request for Quotation from the suppliers finds that **ECV OFFICE SUPPLIES WAREHOUSE, INC.** is the only quoted price and compliant to the requirements required by the government, which is most advantageous to the government for the procurement of the item stated below:
